



Message from the Director of the RCAFA dated 21 Nov, 2024:

The (on-line) meeting of RCAF Association leaders intended for 24 November and to which 18 delegates had already registered themselves, has been cancelled.

The purpose of the meeting was two-fold: 1) to provide the leadership with an update of the ongoing strategic alignment and change management deliberations that began in the Fall of 2023 but in earnest back in February 2024; and, 2) to hold a formal Annual General Meeting mindful of the Canada Revenue Agency (CRA) and Canada Not-for-Profit Corporations Act (CNCA) mandatory requirements for members to approve the annual audit/review engagements, budget report and proposal and to hold annual elections if and where necessary. There are currently eight (8) elected directors and two (2) appointed directors on the board, with one elected vacancy and one appointed vacancy, possibly for consideration at the Board's and the Association's earliest opportunity.

All of these mandates will need to be addressed, when the meeting is scheduled in the New Year.

The meeting is now postponed until after 31 January 2025, at which time the Board of Directors will be pleased to provide a strategic management update and to possibly include introduction of a new Executive Director and new office staff.

Following the meeting of the Strategic Alignment Committee on 4 October 2024, Wendy Song and Dean Black announced their intentions to officially retire with effect from 31 January 2025. Dean has been serving as Executive Director since 16 October 2006, and Wendy since 7 February 2007. This 4-month advance notice of their retirements has provided the association time to begin the search for successors, and a formal handover process may begin soon after 1 January 2025. The naming of a successor to the Executive Director billet may be the subject of a formal announcement early in December, pending the RCAF Association's Board-level ratification of the results of the hiring effort.

Meanwhile, the former Vice-Chairman of the Board of Directors, Colonel (Ret) Terry Chester, CD, has again assumed the role of Chairman, following Mr. Charles Lovallo's late-October decision to vacate the Chairmanship. "Chuck" is now moving his family back to Winnipeg, from Victoria, BC and I join all the RCAF Association members in offering sincere gratitude to him for his devotion and service to the RCAF Association over the past year, and wish him a safe journey to Canada's "centre-of-gravity" aka "WinterPeg!" LOL. We should anticipate more information to follow from Terry on all these matters and more, over the next several weeks.

New state of the art radar arrives at 12 Radar Squadron

On November 7, 2024, 12 Radar Squadron (RS), 3 Wing Bagotville received their state-of-the-art TPS-77 Tactical Control Radar system, the latest-generation mobile long-range radar. This radar is part of a broader plan to modernize the Royal Canadian Air Force (RCAF) and is the same system that 42 RS, 4 Wing Cold Lake received a year ago.

The integration of this modern system into the operations of 3 Wing puts the necessary tools in the hands of our personnel to accomplish the mission and marks a significant advancement in the RCAF's ability to monitor and protect the airspace in which we operate. The radar, featuring cutting-edge technology, has been designed to improve the detection and tracking of aircraft, even in challenging weather conditions, at high altitudes, and at high speeds.

With its advanced capabilities, this radar will enhance the RCAF's responsiveness to potential threats and optimize surveillance missions. Major Sébastien Gagnon, Commanding Officer of 12 RS, expressed his enthusiasm about the integration of this improved capability, "The arrival of this new radar is a turning point for our squadron. It will not only improve our operational efficiency, but also ensure the safety and surveillance of our airspace with unmatched precision." Our operational advantage stems from a force that is mission-ready, combat-efficient, and capable of delivering precise kinetic and non-kinetic effects.



The "Foxes" of 12 RS continue to carry out their missions with the professionalism and commitment that defines Canada's Air Force. Ongoing training is taking place for our personnel to ensure that every member of the squadron fully masters this essential tool.

This new radar is just one of many advancements within the RCAF, demonstrating our determination to stay at the cutting edge of military technology, improve our lethality, and enhance our capabilities to deter, detect, defend, and defeat an adversary before that adversary is capable of the same.
